TwainTowers divides its advisory offerings into two business areas. Through the first of these, its Boards business, Mr. Tschammler will assume mandates in supervisory boards, advisory boards and other such company bodies, as well as in industry bodies and committees. "I see my role primarily in providing stability and guidance and in helping my clients to make the right strategic decisions with a long-term view," says Tschammler, Managing Partner and founder of TwainTowers.

His earlier professional years were at Atisreal (now BNP Paribas Real Estate) in Germany and France, where he ultimately became chair of the company's international investment committee and director of the international investment team in France. In addition to his practical qualification as a real estate professional by the German Chamber of Commerce (IHK), Tschammler holds a bachelor's degree in real estate, as well as a degree in real estate economics from the European Business School (EBS). He is also a Fellow of the Royal Institution of Chartered Surveyors and holds a master's degree in real estate management from Nottingham Trent University / ADI. In addition to his numerous articles and columns in industry and business publications, Tschammler is the co-author of multiple books on real estate as well as a regular speaker at industry events and guest lecturer at universities and colleges with real estate degree programmes.
